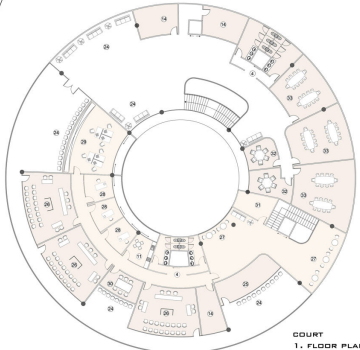
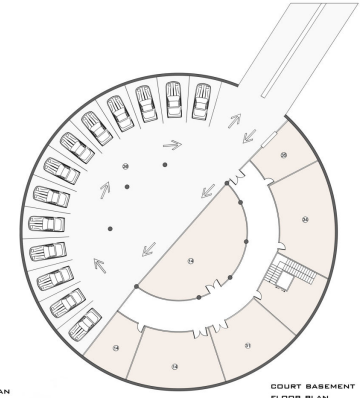


GROUND FLOOR PLAN



COURT 1. FLOOR PLAN



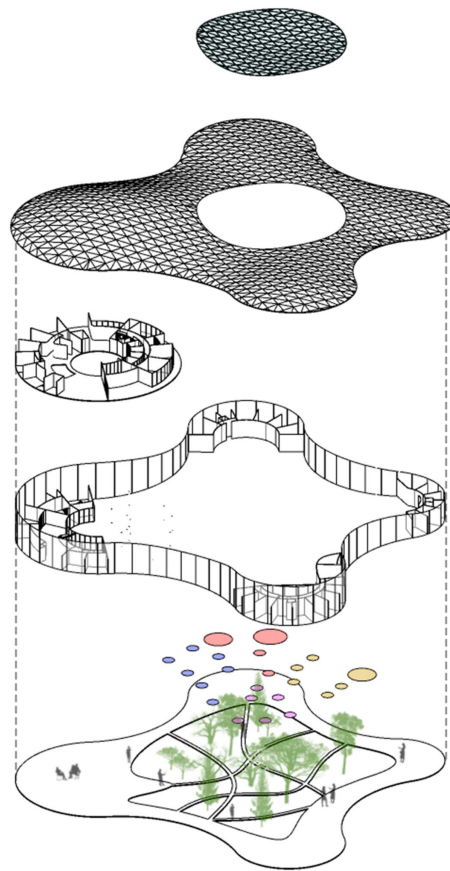

UNDER THE CRUSS SETTLEMENT WAS CREATED WITH THE IDEA OF DIFFERENT FLOOR HEIGHTS OF THE PROGRAMS DISTRIBUTED AND THE IDEA OF CATCHING AN ORGANIC FORM.

ON THE TROPICAL GARDEN IN THE CENTER, THERE IS A GLASS CIRCLE THAT ALLOWS NATURAL LIGHT TO BE RECEIVED. THIS PART, WHICH DECOMPOSED FROM THE SHELL, WAS RAISED 4 METERS FROM THE PART WHERE IT WAS LOCATED IN ORDER TO ALLOW HIGHER TREES TO GROW (LIKE PALM TREES). THIS HEIGHT HAS LEFT A MORE SPACIOUS AREA INSIDE, APART FROM ALLOWING AIR FLOW BETWEEN INSIDE AND OUTSIDE.

THE EFFECT OF THE MAIN TROPICAL GARDEN LOCATED IN THE CENTER WAS STRENGTHENED BY THE INCLUSION OF SOME OF ITS PROGRAMS. SOME PROGRAMS TAKEN FROM THE MAIN MASSES WERE PLACED IN THE GARDEN IN LARGE AND SMALL SIZE. LAW CLINICS, WORKSHOPS, LIBRARY-STUDY AREAS AND MEDITATION AREAS HAVE BEEN ADDED TO THESE CIRCLES, WHICH ARE MORE ISOLATED FROM EACH OTHER AND FROM CIRCULATION.

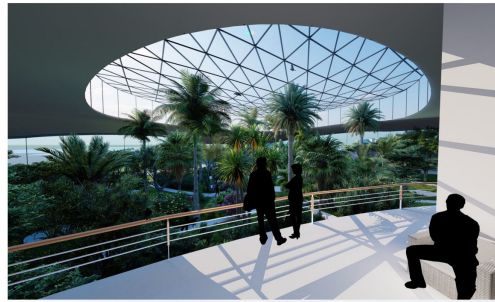
